

CONTRACT OF AGREEMENT

THIS AGREEMENT, made this 27th day of October, 2020 between **TARLAC STATE UNIVERSITY of Romulo Boulevard, San Vicente, Tarlac City** (hereinafter called "the Entity") and **INNOVATIVE CONCEPT MARKETING of Unit B Sureshot Sportville 2848 Jose Abad Santos St. Tondo Manila** (hereinafter called "the Supplier").

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly **Modernization of Laboratory Equipment for Bachelor of Science in Electrical Engineering** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **Six Million Seven Hundred Thirty Seven Thousand Three Hundred Fifty Six Pesos (PhP 6,737,356.00)**

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
 - i. Philippine Bidding Documents (PBDS);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of the Contract; and
 - iv. Supplemental or Bid Bulletins if any
 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - iii. Performance Security;
 - iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
 - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDS. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract**

3. In consideration for the sum of **Six Million Seven Hundred Thirty Seven Thousand Three Hundred Fifty Six Pesos (PhP 6,737,356.00)** or such other sums as may be ascertained, **Innovative Concept Marketing** agrees with the project: **Modernization of Laboratory Equipment for Bachelor of Science in Electrical Engineering** in accordance with his/her/its Bid.
4. The Tarlac State University agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
