Description

1. The Tarlac State University, through the Regular Agency Fund (RAF) and Special Fund (SB) 2024 intends to apply the sum of Six Million Pesos (\$\mathbb{P}\$ 6,000,000.00) to payments under the contracts for the project: Supply, Delivery, Installation, and Configuration of TSU Wi-Fi Modernization for Lucinda Campus (Phase 2).

Bids received in excess of the ABC shall be automatically rejected at bid opening.
